

**NOTICE OF THE 2015 SKATE  
AUSTRALIA VICTORIA

**1. INTRODUCTION**

This Sanction document has been provided to all clubs that have skaters nominating for the 2015 Victorian Inline Speed Skating Marathon. It is the responsibility of the clubs to ensure all skaters nominating do so with full knowledge of the contents of this Sanction.

**2. Dates, times and venues**

**3. Nominations**

- 3.1 Nominations must be forwarded and all registration/nomination fees paid by 11 pm on Friday 2nd October, 2015.
- 3.2 Nominations are to be forwarded to: Frances Wei Lee - clerk@savspeed.com  
Registration and nomination fees must be paid to your club.
- 3.3 Where age determines eligibility for entry in a particular grade, it shall be decided by the age of the skater on 31st December 2015.
- 3.4 Skaters must be a competitive member of Skate Australia.

**4. Fees**

Combined Speed Registration & Nomination Fee for the Marathon is \$30.00 inc. GST

**5. Number Patches**

Skaters are to provide their own speed number patches. Three number patches shall be worn by each competitor – one on the lower back and one on each hip

**6. Suitable Dress for Warm-ups and Events**

Specific rules apply for speed events and the referees shall see that these rules are upheld.

**7. Presentations**

- 7.1 All presentations shall be made, where possible, at the conclusion of the program.
- 7.2 Skaters should assemble in the marshalling area and be ready for the presentation.
- 7.3 Skaters receiving medals must be in full competition outfits (except skates).

**8. Rules**

Copies of all appropriate rules and regulations shall be supplied by the Clerk.

**9. Protests**

- 9.1 All skaters should refer to the appropriate rules as set out by the ASC.
- 9.2 Protest fees must accompany all protests and fees are set at \$100.00 per event. This fee shall be held by the Chairman of the CSOC. Fees shall be refunded if protests are upheld. If the protest is not upheld the money will be deposited into General Funds

## **10. Championship Director**

- 10.1 The Championship Director for the Vic Championship marathon is Mr Igor Zambelli, Chairperson of SAVS.
- 10.2 Technical matters come under the jurisdiction of the Chief Referee or his/her nominee

## **11. Divisions**

- 11.1 The Six Divisions are as follows:
- Open Senior Men (15 and over) marathon 42km
  - Open Senior Women (15 and over) marathon 42km
  - Masters Men (over 27) marathon 42km
  - Masters Women (over 27) marathon 42km
  - Junior Men (under 15) half marathon 21km
  - Junior Women (under 15) half marathon 21km
- 11.2 An event will not be run if there are less than 2 nominations in that division.
- 11.3 Events may run concurrently at the discretion of the Chief Referee
- 11.4 All medallists must complete the distance – however Article 161 of the Road Rules stipulates that the maximum time allowed is 25% more than the winners time – at that time the race will cease and medals awarded only to those who have completed the distance in the allotted time
